Product Description

Wattyl Ultra Ceiling High Opacity White is a tintable, ultra-flat acrylic ceiling paint developed to achieve a smooth, uniform finish on residential and commercial interior ceilings. Free of sheeriness and side sheen, it hides minor surface irregularities. Low in odour and can be recoated in 1 hour.

Surface Preparation

Ensure the substrate is clean and free from dirt, grease, dust, mould, other contaminants or loose material that may interfere with adhesion. Ensure all sheets are installed and joints set as per the manufacturer's installation instructions.

Fill any screw holes, cracks, etc., with an appropriate patching material, sand joints and patching and remove dust according to manufacturer's instructions.

Upon colour selection, to ensure optimum colour match/coverage, the potential use of a tinted undercoat may be required. Alternatively, an additional topcoat might be required. To confirm any colour requirements, contact Wattyl Assist on 132 101. This specification is based on tests carried out on samples supplied. If the condition of the substrate is different, retesting is required to confirm the specification.

Low Absorption Substrates: Previously painted surfaces, off-form concrete over 40 MPa, high density bricks.

Stir contents thoroughly with a power stirrer before use.

Apply one coat to a correctly prepared surface by brush, roller or spray.

AIRLESS GUN SETTINGS: Tip 519 or 521. Pressure Setting 1500-2000psi.

Freshly applied material must be protected from frosts and rain for a minimum of forty-eight (48) hours.

Application **should not** be carried out if the air temperature or the substrate temperature is below 10°C or above 35°C or when humidity is very high. The temperature must not fall below 10°C during the drying process.

In exterior application avoid painting when dew or rain is likely.

Surfaces are to be suitably prepared in accordance with proper trade practices.

Ensure the surface is clean, dry and free from dust, dirt and grease. All loose, peeling or flaking material must be removed. Sand enamel painted surfaces to remove gloss. Fill holes and cracks with a suitable filler and sand lightly to an even finish.

All new cement surfaces need to be fully cured (typically 4–6 weeks) prior to painting. Ensure surfaces are free of bond breakers, formwork release agents and curing compounds.

If mould is present, clean surface with household bleach then rinse well with clean water.

Test soundness of previously painted surfaces by cutting a small X in the paint with a sharp blade. Stick a piece of tape firmly over the X and pull off. If the paint pulls away, the surface is unsound. Repeat at random in a number of areas. Unsound surfaces should be stripped for best results.

Application Guide

Stir well before and during use with a broad paddle reaching to the bottom of the can and using an upward lifting action.

Apply two full, even coats by brush, roller or spray.

Use a quality synthetic brush or synthetic roller.

Use a medium nap (12mm pile) synthetic roller on smooth and semi-smooth surfaces.

Use a longer nap (20mm pile) synthetic roller on rough surfaces, e.g. Besser Block.

Use a 13 or 15 thou Tip for airless spray.

Do not apply when temperature is below 10°C or above 35°C or when humidity is very high.
